Successful applicants: Parents should complete the registration procedures for their child on 10/1(Thu) to 12/1/2017(Sat) by submitting the original of the "2019/20RC" to the Nursery and paying the registration fee HK\$970 2. Applicants on the waiting list: Parents should complete the registration procedures for their child according to the specified date set by the school. Parents are required to submit the original of the "2019/20RC" to the Nursery and paying the registration fee. 3. Please be reminded that if parents cannot submit the "2019/20 RC" during registration, the nursery may not be able to complete registration for their child. Hence, parents are required to submit application for the Registration Certificate to EDB within the specified period. 4. The registration fee for 2019/20 K1 place is \$970. Should parents decide to change school after registration. Please notify the nursery in writing. The Nursery will return the "2019/20RC" but the registration fee will not be refunded. Upon obtaining the "2019/20RC" the nursery will no longer keep the school place for the child.

Application for the “2019/20 Registration Certificate for Kindergarten Admission”

1. Parents are required to submit an application for the “Registration Certificate for Kindergarten Admission” (hereafter referred as “2019/20 RC” to EDB **from September to November 2018.**
2. Under the new Scheme, EDB will use the “Registration Certificate for Kindergarten Admission” as the document for registration in the 2019/20 school year.
3. The “2019/20 RC” will be open for applications in September 2018 and EDB will announce and upload the details of application onto EDB’s website (link to be inserted) in due course.

Admission Criteria

1. Interview performance
2. The applicant with sibling(s) currently studying in the nursery will be given due priority consideration.
3. The applicant from families in need will be given due priority consideration when applying for whole day / long whole day classes. (As the number of school places is limited, please understanding that not all applicants fulfilling the priority consideration will be guaranteed a school place.)
